

GENERAL TERMS AND CONDITIONS OF THE ANZÈRE "100.- BANK NOTE" CONTEST

Organizer: Anzère Tourisme SA

Eligible to participate in the competition: Anyone who is at least 13 years old is allowed to participate. Minor participants must have permission from their guardians. The organizer can verify the existence of such an authorization. The organizer and employees of the organizer, their families, as well as any person placed in professional relation with this contest ("participant") are not allowed to participate.

Participation in the contest does not imply any obligation to purchase goods / services from the organizer, but participants must have a valid Facebook / Instagram account and access to Internet. By taking part in the contest, participants accept those conditions.

Dates of the contest: From 23.09.2019 at 12:00 to 15.12.2019 12:00 (local time)

To participate, participants must take a picture or have their picture taken in front of the interactive wall in the village square of Anzère and post it on Facebook or Instagram with the @anzere or send the picture to 100@anzere.ch.

Only pictures relayed on the Facebook page or Instagram of Anzère Tourisme or sent by email by the end of the contest will be considered. The organizer is not responsible for the non-reception of the answers caused by a technical failure or any other disturbance.

Only one photo per participant will be accepted for the duration of the contest. Additional photos of the same person will not be accepted or taken into account when determining the winners.
